## **JOB DETAILS:**

## **RESPONSIBILITIES:**

- Assist in compliance reviews, general risk assessments and other safety assessments to support Health, Safety, Security, Environment and Quality management.
- Maintain relevant HSSEQ logs and documentation.
- Assist in the compliance of applicable laws and regulations.
- Prepare applicable HSSEQ reports as necessary.
- Provide assistance and advice on HSSEQ issues to make recommendations to facility management.
- Participate in detailed incident investigations and Root Cause Analysis.
- Promote incident prevention for the benefit of employees and visitors.
- Assist in the preparation of training material and the provision of HSSEQ training to all relevant personnel.
- Observe HSSEQ regulations, wears all required safety equipment, encourages safe working practices, corrects obvious hazards immediately or reports them to the proper personnel.
- Ability to work with employees and achieve cultural change in the face of potential resistance.
- Maintain positive and proactive relations with managers and employees, as well as our customers and regulatory agencies.

# ASSIST OPERATIONS MANAGER WITH DAY TO DAY OPERATIONS.

- Assist with expediting customs formalities.
- Assist with fueling of vessel.
- Request Mooring and Unmooring with linesmen.
- Ship chandlery requests.
- Arrange domestic and general waste transport with sub-contractors.
- Any other duties that may be required.

# Perform other work-related tasks as required as assigned

- Comply with all RAMPS/EDO Company and HSE procedures and policies.
- Facility Specific Responsibilities (but not limited to):
- Conduct daily audits of the office and operations and provide required reports to management.
- Visit shore base facilities on a regular basis to establish HSE presence and provide support.
- Conduct daily and monthly HSE Meetings/Trainings and schedule as needed.
- Write, implement, and manage HSE Programs, Policies and Procedures.
- Ability to evaluate PPE and ensure proper use and maintenance of PPE.
- Have knowledge and enforce compliance of Regulatory requirements (i.e. OSHA, Cal OSHA, EPA, etc.) including company HSE policies and procedures.
- Ability to oversee Hazardous Waste Storage area and ensure regulatory agency compliance i.e. labelling, containment, proper disposal, documentation, etc.
- Perform Storm Water Discharge sampling and document events.

- Assist in emergency response and provide first aid treatment.
- Oversee Behavior Based / Observation Safety Programs.
- Assist in the development of Job Hazard Analysis (JHA).
- Follow Fall Protection program, inspect all fall protection equipment and maintain inspection records.
- Up to 20% travel to other RAMPS/EDO locations for meetings, training, inspections, etc.
- Ability to oversee Safety Incentive Programs.
- Assist in administering and maintaining compliance programs such as LOTO, Hazard Communication, and EAP.
- Hearing Conservation, Hot Work, Respiratory Protection, etc.
- Ensure all records are kept for all activities performed under the HSSEQ Umbrella.
- Perform additional duties as assigned by HSSEQ manager.
- Any other duties that may be required.

#### **EMERGENCY RESPONSE FUNCTIONS:**

**Safety Sensitive Duties:** Include but not limited to; directing and mustering employees in emergencies, passing out emergency kits, controlling and operating lifesaving equipment, controlling and operating firefighting equipment.

#### **SECURITY FUNCTIONS:**

 Reports any suspicious activity, behavior, cargo or security breaches to the vessel security officer.
